Course Description	This course aims to provide information about what organization is and how different organizations can be understood, examined, and designed in terms of their various aspects. It describes the key components and features of organizations and identifies the most common approaches to organization design. Understanding organizations is essential to becoming more effective analysts, managers and leaders. In this course we will explore the basic theories and principles around which contemporary organizations are structured in complex, dynamic, uncertain, and competitive environments. The course examines the effects of both the internal and external environment on managerial choices for the structuring of organizations, as well as the implications that stem from these choices. We will explore organization theory with an emphasis on understanding organizations as systems, and on the practical applications of these theories for organization and management. In this course, the primary focus will be the organization itself rather than the individual members who comprise it.	
Aim of the Course	This course aims to provide students with basic knowledge and skills on in which ways organizations can be seen and analyzed and in what ways they can be designed effectively.	
Learning Outcomes	 Students who complete this course successfully are expected to demonstrate sound understanding and knowing how to understand organizations and organizational problems in different aspects. conceive how to design organizations effectively. be able to develop ideas on why organizations might have problems and how they can be functioning better. critically and analytically analyse, examine and evaluate different issues and views regarding organizations.

Plagiarism is a serious academic offence, and therefore the students in such an act may be subject to assignment or course failure, and even permanent expulsion from the school.
